# 10-11 Media Director

## **ANNUAL REPORT OF THE MEDIA TEAM**

### **Introduction**

The Media Team at the United Church of Christ continued to strengthen the way our church communicates, worships, and presents itself in 2025. This year was defined by flexibility, teamwork, and intentional investment in both people and equipment. Whether in the sanctuary, out in the community, or online, the Media Team worked to ensure that every service and event was seen, heard, and represented with excellence.

### **Major Accomplishments**

#### **Portable Sound for Any Space**

One of the most important upgrades this year was the purchase of a Fender portable PA system. This system allows the church to provide clear, high-quality sound reinforcement wherever we gather—indoors, outdoors, or off-site. It has proven invaluable for special services and events where our fixed sanctuary system cannot be used, helping us remain flexible and prepared for any worship setting.

#### **Church Branding and Visual Identity**

In partnership with church leadership, the Media Team helped create a new logo and a comprehensive branding guide for the church. This work unified the look and feel of how the church is presented across all platforms—bulletins, livestreams, social media, and printed materials. Having a consistent visual identity has strengthened our public presence and made our communications clearer, more professional, and more recognizable to both members and the wider community.

### **People and Team Development**

#### **Celebrating Jozie's Internship**

Jozie Kumm continued her outstanding work as our media intern through most of the year, with October marking her final month. We are incredibly proud of her as she stepped into a new professional role at a Sioux City news station. Her growth, creativity, and dedication made a lasting impact on our team, and her time with us was both productive and meaningful.

#### **Building a Volunteer Media Team**

Although we were not able to secure a new intern for the fall semester, this challenge became an opportunity for the Media Team and the congregation to step forward in a new way. By reaching out to church members, we formed a small but dependable volunteer media team and created a sign-up system to ensure every service was covered. Bruce Gray and Tim Ricker became the backbone of this effort, generously giving their time and talents to help run audio, video, and livestream needs week after week. Their reliability and willingness to serve made it possible to maintain seamless coverage of worship services. Thanks to their dedication—and the structure provided by the sign-up system—there was no noticeable drop in the quality or consistency of our media support, allowing worship to continue smoothly for both in-person and online participants.

### **Looking Ahead**

During 2025, we also began discussing the possibility of upgrading the sanctuary speaker system. While no changes were made yet, this remains an important topic for future planning. Improved speakers would further enhance clarity, music, and spoken word in worship, and this is an area worth exploring in 2026.

### **Conclusion**

The Media Team in 2025 demonstrated resilience, creativity, and a strong spirit of collaboration. From investing in portable sound equipment, to building a unified church brand, to successfully transitioning from an intern-based model to a volunteer team, the media ministry remained strong and dependable. We are grateful for everyone who contributed their time, skills, and support, and we look forward to continuing this important work in the year ahead.

### **ANNUAL REPORT OF THE CHRISTIAN EDUCATION COORDINATOR**

The Loaves and Fishes (LAF) program has had another successful year starting the fall of 2025. We begin with a meal that is served on Wednesday evenings from 5:30 - 6:00 PM. Our volunteers have been serving on average 45-60 people. Then from 6:00-7:00 PM the children meet together in the sanctuary for songs and fellowship. Gretchen Burbach taught the students many songs with Paul or Katie on the guitar. At 6:15, the children disperse with different age groups for their various activities. Pre-school - 1st grade, 2nd-5th grade and the BC group of 6th and 7th grade students. Pastor Katie once again wrote a wonderful Christmas Pageant for the children. We had one intern, Charlie Huska, who led the Pre-School - 1st grade group. Lydia Anderson was our leader for the BC Group. The Confirmation II group (8th graders) and Confirmation I group (9th graders) are meeting on Sunday afternoons/evenings from 4:30-7:00 with a meal in between sessions. Pastor Katie leads both groups with Kari Jensen assisting with the Confirmation I group and Pat Flanigan assisting with the Confirmation II group.

We had another successful Bible School in May that was well attended. 35-45 children spent a week doing crafts, learning new songs, and sharing fellowship. Thank you to all the volunteers who help cook, clean, and help manage the children every Wednesday. I am constantly reminded of the amazing generosity and good will that our church family has to offer. I am truly blessed to be a part of the UCC family.

## **ANNUAL REPORT OF THE BOARD OF TRUSTEES**

After no increase to the pledge request for 2025, the Trustees asked for a 4.5% increase for 2026. The stewardship drive came close, so we adjusted the proposed budget to match the pledges that were received. The largest increase was due to doubling of the cost for Pastor Katie's health insurance. We also reduced our OCWM commitment while increase the outreach for our local community. The proposed balanced budget is in the annual report for review.

One of the line items that was reduced to balance the budget was a proposed increase for miscellaneous repairs. While there are many items that now need work after our big campaign a few years ago but two items that stand out. One is the northwest door needs to be replaced, and we would like to add some security to it, both for making access to the church easier, and to improve safety for staff and members. The second is that the north windows also need to be repaired or replaced.

## **ANNUAL REPORT OF THE UCC MUSIC TEAM**

The 2025 spring music team included Gretchen Burbach, Adult Choir and LAF Music Director; Anthony Burbach, piano and bell choir; Michail Chalkiopoulos, organ; and Benjamin Barth, organ intern. January–May choir interns were Shaelyn Laferty, Maleah Wright, and Sam VanGerpen. August–December choir interns included Maleah Wright, Alexis Meyer, and Sam VanGerpen; organ intern, Tommy Gress.

In May, we wished Michail well as he returned to the East Coast to pursue doctoral studies. Benjamin Barth transitioned into the organist role, and we welcomed Tommy Gress as an organ intern.

Keyboard players shared responsibilities accompanying Wednesday evening choir rehearsals and Sunday worship services. In addition to piano, Anthony also represented the music team at cabinet meetings and coordinated piano and organ tunings twice a year, in spring and fall. Anthony continued directing the bell choir, which rehearsed in six-week blocks prior to its featured services in the spring and during Advent. This year, the handbells were refurbished through the generous gifts from the Noble and Hackemer families.

The UCC choir sang weekly through mid-May, offering special selections during Lent and for Palm/Passion Sunday. We presented John Rutter's *Requiem* with chamber string ensemble and organ during an evening Tenebrae service, accompanied by a special offering collected for the Vermillion Emergency Fund.

Throughout the year, Gretchen worked closely with LAF session music, collecting, creating, preparing, and sharing youth music for LAF Celebration Sundays and Vacation Bible School, *Created to Create*.

Following VBS, the choir took a summer break, and special music was offered each Sunday to complement Pastor Katie's summer sermon series, which paired scripture with music ranging from show tunes to hymns. This season also provided opportunities to welcome young adult singers home from college to share their talents through solos and duets.

The UCC choir values opportunities to connect with the wider community. This year, we collaborated with Trinity Lutheran and the Methodist churches for an ecumenical outdoor service (later moved indoors), joined with the Social Justice Choir for the Pride Service, and shared caroling at the Care Center and Dakota Gardens. We were especially excited to collaborate with the USD Theatre Department by sharing service music with the cast of *Bright Star*. As part of a cherished tradition, the USD Chamber Singers shared music during two UCC services following their semester retreats. Additionally, UCC enjoyed special music from the Vermillion Community Theatre cast of *Shrek* and the Vermillion Children's Choir.

The winter of 2025 offered a unique opportunity for UCC musical groups to come together. December weather events prompted us to reimagine both Bell Choir Sunday and UCC's 83rd Annual Carol Service as a single, combined service. The result was Hal Hopson's *Festival of Lessons and Carols*, featuring soloists, chamber ensemble, bell choir, and organ, with guest narration by Rich Hall. Christmas Eve worship included music from a "pop-up choir," an acoustic string trio, vocal duets, and congregational carols accompanied by piano and organ. New gold choir stoles were purchased through the Carol Service Endowment Fund.

The UCC Music Team looks forward to continuing our work of offering a wide variety of music through our ensembles while welcoming musical guests from the university and community. We are deeply grateful for the singers and instrumentalists who share their gifts throughout the year. With sincere appreciation for the continued support from our congregation, we remain committed to thoughtfully and prayerfully selecting music that enriches worship and fills the hearts of all who listen.

### ANNUAL REPORT OF THE ENDOWMENT COMMITTEE

The Endowment Fund Committee is charged with oversight of the investments for the Endowment Fund and determining the annual payout from the two accounts comprising the Endowment Fund. The endowed funds are invested with the United Church Funds, the organization that invests money for many churches and organizations of the United Church of Christ. We began working with the United Church Funds in 2006. Our assets are invested in the UCF Balanced Fund which provides a 60% exposure to diversified equity markets and a 40% exposure to high quality fixed income vehicles and cash. The performance of the endowment mirrored the performance of the markets in the same time frame. The current members of the Endowment Committee are Ken Green, Adam Chandler, Don Dahlin, Jake Kerby, and Greg Redlin. The committee was asked to consider a payout of either 4% or 4.5%. We unanimously voted to provide 4.5% to the Trustees based upon the positive returns the previous year and the needs of the church. This amounts to \$24,878 - \$23,190 to the building endowment needs, and \$1688 to music needs (based upon amounts in the separate funds).

## **ANNUAL REPORT OF REV. KATIE MILLER**

This past year has been one marked by deep gratitude.

In a world that continues to feel heavy — with rising costs of nearly everything, ongoing conflict both globally and close to home, and a constant undercurrent of uncertainty — I am profoundly thankful for the community we continue to nurture together at UCC Vermillion. In many ways, the church has been a place of steadiness amid so much change: a place where people are known, where laughter and sadness can coexist, and where faith is not an abstract idea but a lived practice.

What we have created together is not small. We have cultivated a space that feels like home. We are a community that shows up for one another, that welcomes questions as much as convictions, and that continues to embody what it means to be a positive presence in Vermillion.

One of the most meaningful dimensions of this past year has been our growing engagement with the wider community. Our ecumenical worship services have been a powerful sign of unity beyond denominational lines, especially in a time when division feels so pervasive. Hosting the Ecumenical Pride Service last summer was a particularly holy moment, and not only as a public witness of affirmation and love, but a tangible reminder that church can still be a place of refuge, celebration, and justice.

Our commitment to caring for neighbors in need has also remained strong. The work of this church does not depend on certainty or comfort; it depends on faithfulness, on showing up, and on trusting that love is still worth practicing in public.

This congregation has a strong heart, a resilient spirit, and a deep capacity for care. I am grateful for the way you continue to embody what it means to be church — not as a building or a program, but as a living community committed to one another and to the world God so deeply loves.
